ONE DRIVER AND ONE BIKE PER POLICY. THE ONLY EXCEPTION IS FOR THE SPOUSE OF THE NAMED INSURED.

BIKES VALUED AT OVER \$40,000 CAN BE INSURED FOR LIABILITY ONLY. NO PHYSICAL DAMAGE COVERAGE IS PROVIDED.

BIKES OVER 2500 CC'S ARE UNACCEPTABLE.

A SIX WEEK COVERAGE IS AVAILABLE TO DETERMINE THE PREMIUM, TAKE THE ONE MONTH PRICES AND ½ THE SAME AMOUNT AND ADD THEM TOGETHER.

- 6> DATES OF DEPARTURE AND ARRIVAL OF THE MOTORCYCLE TO AND FROM.
- 7> CIETIES OF DEPARTURE AND ARRIVAL FOR THE MOTORCYCLE TO AND FROM.
- 8> GARAGING INFORMATION IF THE MOTORCYCLE WILL REMAIN IN THE U.S.
